# **Summary of the November 2020 Board of Governors Meeting** and the December 2020 Membership Meetina

#### Wednesday, November 18, 2020 - Board of Governors Meeting

The meeting was called to order at 8:30pm.

- President's Report President Ron Marchessault discussed major Chapter activities.
  - o Hunting Rule #12 changed to accommodate straightwalled cartridge rifles and handguns for MD Firearm Deer Season, only.
  - o Hunter Rule #9 changed so that all hunting equipment including ground blinds are to be removed every day after use or owners risk confiscation.
  - o 2020-2021 Bird Feeder watch Season began on November 14th.
  - o Advanced Planning & Finance Committee Meeting wass held on November 14th. Two major programs discussed - controlling Invasive Species Program and review and update Lead Management Program.
- Treasurer Bill Brockman presented the Sandy Spring Bank account balances to the membership. Financials are being digitized. IRS filings submitted to maintain compliance.

#### ITEMS FOR DISCUSSION - Not Requiring a Vote

Funds in support of Farmers and Hunters Feeding the Hungry, already committed on budget last Summer, will be sent soon.

#### **NEW BUSINESS** – Items Requiring a Vote

- **CAPEX Priority Projects** all 3 priorities were approved by unanimous vote – remote clay pigeon controller, new trap machine, and repairs to archery target shed, bridge, and picnic tables.
- Twenty new members were unanimously approved.

#### TALKS FOR THE GOOD OF THE CHAPTER

- Butch Mezick led a discussion regarding the annual Land Fund telethon with December 13 as the target date.
- The President thanked the Board and wished all a happy and safe Thanksgiving.

The meeting was adjourned at 9:18pm.

#### December 16, 2020 - 1,022nd Membership Meeting

The meeting was called to order at 6:45pm.

- President Ron Marchessault gave an overview of the proceedings of the Advanced Planning and Finance Committee (AP&FC) meeting held on December 5, 2020. This meeting was focused on long-term lead management at the Chapter, incorporating EPA's 4 steps for shooting ranges: Control, Prevention of Migration, Reclamation and Documentation.
- Membership Report: Twenty-seven prospective members introduced themselves. Members were reminded to log in work hours electronically.
- Past President Jeff Seaman provided an update on the Zoning Text Amendment (ZTA) proposed for designating 3 square miles of land in the Ag Reserve to solar energy. Working group meetings are accessible online, although participation for outsiders is passive only. One or two more

of these meetings are planned before a potential council vote in January. Interested Members can access the Planning Committee and Montgomery County Alliance websites for more information.

- Chestnut Committee: Hybrids planted in B2 are expected to provide mast in 7-8 years. New germ plasm stock planned for Spring planting in orchard near greenhouse. Maryland Chapter would like to put potted hybrids in greenhouse.
- Wildlife Management Bow season for deer continues through January 30, 2021. Chronic Wasting Disease has been identified in Loudon Co., but Blue Tongue disease not identified locally. Notify DNR if suspicious of same in MoCo.
- Security Committee Members reminded not to park in fire lane, and not to off-road vehicles. New lights, new cameras, laptop, and software planned.
- Legislation and Public Relations The County Executive's broad Climate Action Plan, proposing to cut greenhouse gas emissions 80 percent by 2027, is available for review and comment on the County Exec website. The comment period is until the end of February.

#### TALKS FOR THE GOOD OF THE CHAPTER

 Fifteen new Members were sworn in and the Oath was administered by First VP Lin Tate.

The meeting was adjourned at 7:58pm, with the December BOG meeting to follow at 8:15pm.



# **Legislative Committee Report**

There are two important pieces of legislation - one recently enacted and one pending – that will have significant effects on the Agricultural Reserve.

ZTA 20-01, the proposed zoning text amendment which would permit up to 1,800 acres of solar panel arrays in the Agricultural Reserve. We, along with other conservation groups (like Montgomery Countryside Alliance, Audubon Society and the Montgomery Agricultural Producers), opposed the text amendment as written because of the threat its implementation would pose to agriculture in the Reserve. In a nutshell, there was concern that solar arrays would end up on otherwise productive agricultural land; farmers who lease land would likely be unable to compete with much more lucrative offers from out-of-town solar energy companies and traders with no stake in the integrity of the Reserve. In addition, the ZTA overlooks the importance of the Reserve to the region's food production independence and security. The opponents recognize the need to move to solar power (many farmers are already using solar) but think the ZTA ignores the competing value of the land that would be removed from agricultural use if the ZTA passes as written, and contravenes the original intent of the creation of the Reserve. Solar should be limited to an accessory use to agriculture.

There has over the last year been much discussion between the Council, the solar industry (joined by the Sierra Club) and the agricultural community, and some members of the Council have been particularly sensitive to the concerns of the agricultural community. The Council has appointed a working group of agricultural and industry representatives to try to work out a compromise. The working group's recommendations will go to the Planning, Housing and Economic Development and Government Operations and Fiscal Policy Committees (PHED - Riemer, Friedson and Jawando; GO - Navarro, Friedson and Katz). The PHED and GO Committees will then work together to make a recommendation to the Council. Bob Cissel, who has been involved with the ZTA from the beginning, and who is involved with the working group, has attended all the meetings.

Bill 32-80. County Executive Elrich vetoed the bill on November 30, but on December 8 the Council overrode the veto on this bill which, among other things, defines "agricultural facility" so as to reduce the tax rates on uses such as farm markets, accessory breweries, wine-making facilities.

The County Executive has recently released his Draft Climate Action Plan. It is very broad in its focus, encompassing approaches to energy, building and development, transportation, carbon sequestration, governance, public engagement and education, demographics and environmental justice. The ambitious aim of the Plan is to reduce the County's greenhouse gas emissions 80% by 2027 and 100% by 2035. The Plan is built upon recommendations by the Climate Workgroup. The Workgroup recommended, among many other things, protection of forests and agricultural lands - good news. But there is much more to the Plan, and we encourage you to set aside some time to look at the Plan. Within the Workgroup's web page is a wealth of information and wide variety of resources for further study for those inclined. Planners have solicited public comment on the plan. Comments are due by February 28. The Draft Plan is available through the County's website.





So, please make sure that you get your 2021 membership renewal in as soon as possible if you haven't sent it back yet.


Along those same lines, please be patient waiting for your 2021 IWLA membership cards. Almost every step in the renewal process involves mailing something to someone.



### **Black Powder / Muzzleloader Event**

Muzzleloading enthusiasts will gather for the annual Black Powder Clinic and Shooting Match, Saturday, March 27, 2021 from 9:00am - 4:30pm.

Did you receive a blackpowder firearm as a present and don't know what to do with it? Are you ready to test your skills against others in the afternoon shooting match and compete for prizes? Don't miss out on this marvelous opportunity for knowledgeable instruction, loads of fun, and the unique smell of blackpowder smoke!

Participants will meet at the Rifle & Pistol Range at 9:00am. Inlines, percussion or flintlock shooters are all welcome. There will be instruction time for new shooters or those with new muzzleloaders while "veterans" and more experienced shooters will sight-in their guns.



Bring the muzzleloader that you want to shoot or let Mark Gochnour know in your email that you would like to try one out so he can arrange for a loaner. Learn directly from individuals having experience and knowledge. (Mark certified is NRA/NMLRA Blackpowder

Instructor.) If you have never fired a black powder gun or you have one you have never used before or are having issues with one you have forgotten about in the gun safe, come during the morning but stay for the shoot! Last year, one shooter used a loaner gun to compete in the shooting match and turned out to be excellent marksman!

Lunch will be served in the Chapter House around 12:00 noon with the shooting competition beginning at 1:00pm.

Match Participants will be provided opportunities to shoot at some unusual novelty targets again this year, including last year's favorite - The Flopping



Plate. Targets will be shot at a variety of ranges from up close and out to 100 yards with prizes awarded to individual shooters. An overall Grand Prize could be a frozen turkey or ham.



Due to safety issues, only muzzleloader shooting participants will be allowed to use the Range since the availability of shooting lanes may be limited. (After the afternoon shooting match, Range Officers and their guests may shoot.)

#### **Christmas Bird Count**

On December 20, we once again hosted the Montgomery Bird Club (MBC) for a portion of the Sector 7, Seneca Christmas Bird Count (CBC), an annual nationwide event since 1958, organized by The Audubon Society. Ten Bird Club birders, plus six chapter members, gathered on the Conservation Farm at 7:00am, then set out in two groups for the morning's count. Montgomery Bird Club member Jim Nelson was the Seneca CBC compiler and organizer. Larry Anderson and Scott Harmon escorted the two parties through the west woods and the fields. Separately, Jim and Lin Tate and Tucker Mostrom, counted birds frequenting the feeders behind the chapter house. The feeder count was submitted to the Lab of Ornithology at Cornell University in connection with our FeederWatch project as well as included in Sector 7's total.

The two MBC groups walked the chapter grounds until noon in chilly weather, overcast with temperatures mainly in the low 30s. Combined, the field counters and the FeederWatchers tallied 38 species and approximately 500 individual birds. A major highlight this year was the American Woodcock, a rare bird for the entire Seneca Count Circle and one seen only every few years. An astounding forty-four Eastern Meadowlarks were spotted in one of the fields, the largest number of meadowlarks counted in the Seneca Count Circle going back as far as 1987! The American Woodcock and Eastern Meadowlark were not found anywhere else in the Seneca Count Circle. Other species not often seen in winter at the farm were an American Kestrel, a Brown Thrasher, and a Chipping Sparrow. The highest number of birds observed this year in a species were the following: American Robin, 86, European Starling, 55, White-throated Sparrow, 51, Eastern Meadowlark, 44, and Canada Goose, 43. Preliminary data for the entire count circle show 104 species, the largest number of species recorded since 2001, and about 6,950 total birds. The chapter made a significant contribution to the total species counted.

# **2020 Ponds & Streams Activities Report**

The year 2020 was unusual for the Ponds & Streams Committee due Covid-19. However, when the chapter reopened for mostly outdoor activities with social distancing, a number of projects were completed by Ponds & Streams' volunteers. The following summarizes those projects and activities completed during 2020.

February and March. During February and March, three contractors inspected the big pond's overflow basin to determine repair needs because, over the years, the basin has experienced erosion to the point where it was no longer effectively containing flows during high runoff events. M.S. O'Neil & Sons, selected as the contractor to do the work, planned to begin work once the ground dried.

April and May. Covid-19 prevented the Chapter from conducting the April spring cleanup; however, Ponds & Streams volunteers were still able to conduct some work. Woody saplings were cut along the big pond dam. Twenty-one buttonbushes were planted around the small pond and twentynine were planted around the big pond. Tall grass was cut along the shorelines of both ponds. About 30 bluegill fry, flushed from the big pond during high flow events in May, were rescued from the overflow basin and returned to the big pond. Weekly fish feeding was started at both ponds. On May 17th, bluegills were observed spawning on one of the 10 X 10 foot spawning beds placed in the big pond in 2018. At least 20 beds were counted.

June. Discarded fishing line with a hook attached was found along the big pond shoreline. Because this line could have been hazardous to wildlife, pets, and kids, a note was placed in the July newsletter advising anglers to pick up any discarded line. A receptacle was placed at both ponds for disposing of used fishing line. On June 14th, Larry Anderson noticed a heavy accumulation of algae and scum on the big pond. An inspection of the big pond on Monday by John Novak on June 15th confirmed Larry's observations. Floating mats of algae on the surface appeared to be blue green. On June 16th, Chris Luckett, an algae specialist with the Maryland Department of the Environment (MD DE), was notified and, on June 19th, he came out to the big pond and took an algae sample. Later in the day he provided a preliminary report on the results of his analysis, which confirmed the presence of blue green algae with at least two toxic species. Results of an analysis of the blue green algae for the toxin microcystin revealed a microcystin concentration of 115 parts per billion (ppb) which is well above MD DE's standard of 8 ppb for a contact advisory. Chapter members were advised to avoid contact with big pond water and to keep dogs out of the water until re-testing for toxins was completed and the water deemed safe. Observations of the big pond on June 28th, showed no blue green algae and, after discussion with Chris Luckett, the okay was given for the free fishing day on July 4th. The chapter advised members that the big pond was open for fishing but contact with the water should be avoided by humans and dogs and hand washing or use of hand sanitizer was recommended. During June, about 30 bluegill fry were rescued from the overflow basin and returned to the big pond.

July. Bluegills were observed spawning on July 5th on two beds near the big pond shelter; this was the second spawning event for 2020. On July 14th, construction to repair the overflow basin began. On July 15th, Chris Luckett took a water sample from the big pond for an algae analysis which did not reveal any substantial concentration of blue green algae. A toxicity analysis on the sample showed a toxin concentration of 0.15 ppb which is insignificant. Based on these results, an all-clear notice for the resumption of normal activities and dog training was sent to the chapter membership. After replacing a pump and the timer and further trouble shooting, Kevin King was able to get all three aerators working at the big pond. The small pond aerator experienced no apparent problems. The contractor finished work on the big pond overflow basin on July 25th.

August. On August 1st, projects completed included removing a tree that had fallen over the trail upstream of the big pond solar panel, anchoring a turtle platform in the big pond, cutting some of the multiflora rose on the big pond dam, and placing stakes at the buttonbushes along the small pond shoreline. Phil Taylor filled in the large hole/depression near the big pond shelter with dirt. On August 15th, the debris partially blocking the entrance of the culverts at the first crossing on Izaak Walton Way was removed and the aged wood on one of the picnic tables under the shelter was replaced. Two minnow traps were set in the big pond and 70 bluegill fingerlings were caught, indicating successful spawning. On three different occasions, minnow traps were set in the small pond; less than a total of 10 bluegill fry/fingerlings were caught, indicating possible predation. Also, the low number of bluegill fry/fingerlings may have been due to poor spawning success.

October and November. On fall cleanup day, October 3rd, the following projects were completed: grass seed was planted around the big pond shelter and in the dirt that filled the hole/depression near the shelter, some branches on an overhanging tree near the shelter were trimmed, a weighted brush pile was placed in the big pond, six rose mallows from the big pond were transplanted around the small pond, 40 bluegill and redear fingerlings were caught below the overflow basin and released into the big pond, the turtle platform was removed from the big pond, a dead tree that had fallen into the big pond near the solar panel was removed, and tall grass along the shorelines of both ponds was trimmed.

Save Our Streams. A report on the 2020 stream monitoring program prepared by Dominic D' Ambrosi appeared in the December newsletter.
