Summary of the July 2021 **Board of Governors Meeting and the August 2021 Membership Meeting**

Wednesday, July 28, 2021 - Board of Governors Meeting

- Recording Secretary John Stinson was unable to attend this meeting in person and any gaps or inaccuracies in these minutes reflect the poor audio quality experienced with remote attendance.
- After discussion of a personnel matter and the nominating process for the Board under executive session, the meeting was called to order at 8:20pm.
- The Board was presented with a detailed plan for Log Cabin restoration. A written proposal will be submitted in the future for CAPEX consideration.
- The Board reviewed advice provided by environmental legal counsel Tony Gorski regarding notice and approval requirements for planned lead reclamation. This is allowed under the Montgomery County Rural Legacy Conservation Easement, as the outdoor shooting ranges had been operational for decades at the time the Easement was created. Mr. Gorski's analysis is ongoing, and he will address the Board in the near future.
- The Chapter will need to notify the Montgomery County Rural Legacy Conservation Easement holder and obtain permission for lead reclamation on the shot fall zone of the Shotgun Range, as this will involve forested land and buffer strip. Before submission to the Montgomery County Department of Permits for a Sediment Control Permit for the Shotgun Range lead reclamation, an Environmental Consultant will be required to draft a plan ensuring that the Sediment Control Application has been reviewed and conforms with all Federal, State, and County regulatory guidance compliance pertaining to said easement including all relevant information, supporting documents, photos, maps and diagrams.
- The Chapter has submitted a Sediment Control Application to the Department of Permitting Services for the R & P range and will do so for the Shotgun Range when appropriate.
- Meanwhile, the Easement holder made a recent site visit and their feedback regarding these plans was positive.
- A Chapter Member suggested that a motion be made to support a proposed state bill providing funding for a decade-long tree-planting project. IWLA chapters, sister organizations, and individual lkes would contact legislators accordingly. This Member will draft a letter for consideration.
- Farm Chair Phil Taylor and others on the committee proposed acquisition of a Davis Weather Monitor. This consists of solar-powered hardware with multiple sensors (soil temp, wind, leaf wetness, forecast, historical data etc.) and a gateway to a cell tower. Also for consideration is a custom weather web page linked to the Chapter website. Phil will write up a proposal and submit it to the 2nd VP for AP & FC and CAPEX consideration. Such proposal should include a justification with explanation of the benefits of this to the Chapter.

NEW BUSINESS:

A motion was made to transfer funds from the Operating Account to CAPEX to pay the Promissory Note by mid-(continued on page 3)

August to the BCC IWLA Legacy Foundation for the Large Pond Spillway Project. Payment of the said note was due no later than August 31, 2021. This motion passed.

- A motion was made and passed to accept qualifying new members.
- Dues increase: The president predicts that in 15 years, 2 million more rounds will have been fired, triggering another lead reclamation, with a marginal offset for reclaimed lead. In addition, provision must be made for large-scale CAPEX exigencies such as a new roof for the Chapter House, tractor replacement, etc. The Board therefore agreed that a dues increase is warranted for CAPEX accrual. After discussion using a revenue projection tool, a motion was made to increase annual individual member dues by \$15, with proportional change to other membership categories. This motion failed to pass.
- A motion was made to present to the membership an increase individual annual dues by \$20 with proportional change to other membership categories. This motion passed.
- The Board reviewed changes to the Chapter bylaws reflective of the proposed dues increase. By email the bylaws amendment was edited and consensus was reached on July 31, 2021. However, no motion was made to accept the proposed bylaws changes.
- The Board discussed increasing the financial penalty for work hour non-performance. Although this has not been changed since 2006 but will be tabled for now.
- The Board discussed the verbiage for an announcement to the membership regarding the dues increase in detail. The president subsequent to this meeting submitted to the Board a draft announcement, along with the proposed change to the bylaws. After minor edits these were submitted for a blast email to the membership.

- President Ron Marchessault provided an update on lead reclamation progress on the R & P range.
- Past President Jeff Seaman administered the Oath and swore in the BCC Board for 2021-22.
- In lieu of a featured speaker, the gun raffle was held, and the 3 winners were announced after randomized selection of their tickets. Proceeds of the raffle will accrue directly to CAPEX account.
- Past President Seaman and President Marchessault presented National, State, and Chapter awards for 2019 and 2020 respectively.

NEW BUSINESS:

- Three items requiring votes for adoption were brought to the floor:
 - 1. A motion was made and seconded to increase dues for individuals by \$20.00, with proportionate increases in other membership categories. This motion was debated, and it was reinforced that this increase is to accommodate lead reclamation in the future, as Legacy Foundation grant money for the current effort is a oneoff. Following E.P.A. Guidelines, the Chapter is expected to require another lead reclamation in approximately 15 years, having expended another 2 million rounds by then. In addition, long-term high-ticket CAPEX projects may be thereby funded. It was necessary to limit the debate to the merits of the motion. The motion passed, 41 Y, 14 N.
 - 2. A motion was made and seconded to amend the Chapter Bylaws to align with creation of a separate long-term CAPEX account to accommodate the above motion to reflect that Capital funds separately accounted for as the Near-Term Capital Fund and Long-Term Capital Fund shall be established. The motion passed 36 Y, 16 N. Article 9, Section 3 of the Bylaws will be amended accordingly.
 - 3. A motion was made, and seconded, to approve the 2021-2022 Chapter budget. The motion passed unani-



Big Pond Largemouth Bass (LMB) Removal

One of the recommendations made in the report following our May 13, 2021, big pond electrofishing study was the removal of LMB 8"- 12" in length. The study found an overabundance of LMB in this size range. To meet the Chapter's management plan for the establishment of a quality LMB fishery in the big pond (size and numbers in the 5-pound range), it is imperative that concerted efforts be made for the removal of 8"-12" LMB in order to reduce competition for the forage base. Implementing this management measure would allow the larger bass to grow to trophy size and the smaller 4"-6" bass to fill the gap left by removal of the 8"-12" bass. At present, anglers are not allowed to remove LMB under 12 inches from the Chapter property since the minimum possession size for LMB per Maryland Department of Natural Resources (DNR) regulations is 12 inches. This size restriction also applies to the Chapter's small and large ponds. An application for a Fee Fishing Lake Permit has been submitted to DNR which, if approved, will allow anglers to remove 8"-12" LMB from Chapter property. This application is still pending. Therefore, anglers are strongly urged to assist in the implementation of the recommendations made in the electrofishing study report and remove all 8"-12" LMB from the big pond either by transporting them to the small pond or simply by disposing of them in the woods where they will be quickly consumed by raccoons, foxes, coyotes, and birds. Rest assured, the removed bass will not go to waste. Every LMB removed will contribute toward meeting the Chapter's management plan for the establishment of a high-quality big pond fishery that will greatly benefit all anglers. Measuring boards have been positioned in the big pond shelter for anglers to determine fish length. In addition, anglers are strongly requested to enter into the logbook the number and size of all LMB removed from the big pond. Any questions or concerns about removing LMB from the big pond can be directed to either John Novak or Pete Wirth, Co-chairs of the Ponds & Streams Committee.

Summer Biathlon Program

ELIGIBILITY: Summer Biathlon is open to all B-CC IWLA members 12 years and older, as well as, sponsored guests. BCC-IWLA members no range fee. Non-member rate is \$5.00 per session. For those who are not members of B-CC IWLA, the hold harmless document can be found on the B-CC IWLA website (bcciwla.org). This needs to be filled out each day you come to shoot or you cannot shoot. Minors need the signature of a parent or legal guardian.

EVENT: Running distance at B-CC IWLA is set at 5 kilometers (3.1 miles) split into 5 loops. A short course for those working up to the other distances has been laid out as well. The regulation shooting distance is 50 meters. Targets are also set between 25 and 50 meters for development of the shooting art. There are four shooting stops on the 5km course. Shooting stops alternate between prone (lying down) and off-hand (standing) positions. Five rounds are fired at each stop for a total of 20 shots. An equal number of shots are fired from each shooting position.

SCORING: Scoring is based on a time to complete basis. A penalty of either one (1) minute or a 50-100 meter penalty lap will be assessed for each shot missed.

EQUIPMENT: .22 caliber biathlon rifles are the standard; however, any magazine fed, .22 caliber rifle with either bolt or lever action is permitted. Only standard velocity .22 caliber target ammunition is allowed.

SCHEDULE



2021 NestWatch Wrap-up

Nest sites monitored in 2021: 72

Total nesting attempts all species: 84; eggs: 436; young: 354; fledglings: 341

Species monitored: Purple Martins, Tree Swallows, Eastern Bluebirds

Once again, the Purple Martins enjoyed a productive breeding season at the conservation farm: 42 nesting attempts produced 234 eggs, 185 young, and 177 fledglings, 24 more than in 2020. The first martin egg was laid on May 8 and the last clutch fledged in early August. We saw no evidence of snake predation, or House Sparrows, which compete for nesting space and pierce martin eggs. We believe there were no losses to owls or other avian predators. In sum, the martins had a very healthy breeding season.

The Tree Swallow and Eastern Bluebird fledglings increased by about 15 young each from 2020. Tree Swallows laid their first egg on April 29 and saw their last clutch fledge in July. Eastern Bluebirds laid their first egg on April 22, almost a month later than last year's first egg date. Their last brood of four nestlings fledged in mid-August.

This year for the first time we paired three field boxes by placing a second box just inches from the first and supported by a single pole. One of the pairings had nearly simultaneous Tree Swallow and Eastern Bluebird nests. This pairing achieved our goal of reducing the competition between the two species which we had witnessed in previous

We are grateful to Tom Lamkin and Phil Taylor for keeping the grass around the boxes so well trimmed. And thanks to Larry Anderson for obtaining six additional gourds ("supergourds"), which were installed on the gourd system pole.

Congratulations to our Conservation Partner



Rick Wilson, founder of Farmers and Hunters Feeding the Hungry, (FHFH) has been selected to receive the 2020 William Donald Schaefer Helping People Award for his humanitarian feeding program.

Twenty-three years ago, Rick founded FHFH to provide donated meat to starving families in underserved communities. Venison and other big game is nutritious, low fat and high in protein. FHFH has grown into a nationwide initiative; saving countless lives and combatting food insecurity every single day. (https://www.fhfh.org/FHFH website).

In this video https://youtu.be/VqFZ_MfYhDM, Rick Wilson, Executive Director and Founder of FHFH, recounts his experience many years ago that provided the idea for FHFH. Rick was about to begin an incredible journey — a mission to feed hungry children that would involve thousands and feed millions.

Hunters provide legally taken deer to FHFH as their home freezers fill up. Game that is donated to the program are inspected by a qualified meat processor that is contracted by FHFH. Cash donations support the professional processing of harvested deer.

The Bethesda-Chevy Chase Chapter of the IWLA has actively partnered with FHFH for more than a decade to donate venison to local feeding charities. Our partnership fills a special donation niche. Food banks, food pantries, and feeding ministries tell us that fresh meat is one of the hardest commodities for them to acquire.

Feeding others - part of the heritage of hunting – is now being passed on to a new generation of hunters. Young people nationwide are surprising their parents by donating their first deer to help feed the hungry (https://youtu.be/eSsXKr5MPAc).
