As of the September Board Meeting, membership stands at 790 total Members: 431 Individuals, 262 Family, 6 Students, 1 Youth, 76 Retired, and 14 Associates.

All renewal notices have been mailed and renewals are coming in. By renewing early, you help the chapter continue operating the farm and ranges during the fall months. There are three ways to renew.

- 1. By mail
- 2. In person at a dinner meeting
- 3. Online

The mail method is easy but takes extra time for delivery and pickup. You increase your exposure to identity theft by writing a check and mailing it. This is now the most common way to have your banking information stolen. My wife works in bank fraud, and this is the number one way criminals steal your identity and it is on the rise.

The second way is to see me at a dinner meeting and hand me a check. This is a more preferred way to renew and will require a copy of your renewal notice.

The third way, and most preferred way, is to renew online. To renew online, go to our web page bcciwla.org. Click on the drop down menu at the upper right side of the webpage named Member Area. At the bottom of the drop down menu you will see Renew Your Membership. Have your renewal notice handy for your membership number and dues total. Enter your name, address, and preferred email so we can check them against our database. Next go to the payment area and put in your dues amount. You can also choose to donate to the chapter General Fund or Land Fund. Your donation will be 100% tax deductible. Lastly if you did not work 6 hours at the chapter, add \$50 to the Volunteer Fee area. Then click on PayPal and pay your dues.

Please choose the method that works best for you but also helps the chapter the most.

Work hours may be added to our database online as well. On the main website page go to Member Area and from the drop down menu click on Log Your Volunteer Hours. No worries if you have not worked 6 hours yet. The fall chapter cleanup is a great event to log those needed hours.

#### **Summary of the August 2023 Board of Governors Meeting and the** September 2023 Membership Meeting

#### Wednesday, August 23, 2023 - Board of Governors Meeting

- President Walt Allensworth called the meeting to order at 7:00pm.
- Attorney Anthony Gorski (Tony) called in.
  - Shotgun Range update: Tony Gorski stated that he had read the request to re-open the range on a limited basis and since the initial closure was due to lead going into the stream buffer and newly discovered wetland buffer and not the lead reclamation he did not see any problem with re-opening as long as the layout does not put lead into the sensitive areas.
  - The sporting clays course will be set up so the targets travel in set patterns and the shooting positions are fixed so the shotfall is not landing in the sensitive areas. The locations of the machines and shooting positions will be located and marked. The Range officers will be instructed not to change the course without prior approval.
- Dan Dutton, Handbook Committee Chair, reported that he is getting the existing Handbook in a word document from Butch Mezick so he can start editing.
- Log Cabin Chair David Mecklenburg reported that he has seen termites at the cabin and wants to have pest control take a look.
- Chapter House Chair John Lamb reported that the UV water filter light in the chapter house has been replaced and he is arranging for the one at the Archery Range to be replaced also.

#### **NEW BUSINESS (requiring a vote):**

- Motion was made to donate \$500 to the Upper Montgomery County Volunteer Fire Department in Beallsville. The motion was seconded and passed unanimously.
- Motion was made to accept one applicant for membership into the chapter. The motion was seconded and passed unanimously.
- Motion was made to grant permission to the Montgomery County Planning Department to explore for a possible cemetery between the apiary and the log cabin, using dogs and ground penetrating radar. The motion was seconded and passed unanimously.
- Motion was made for the chapter house and grounds to be used by Hunter Safety on May 4 and 5 and September 7 and 8, 2024. The motion was seconded and passed unanimously.

#### TALKS FOR THE GOOD OF THE CHAPTER:

- Dan Dutton asked about putting up some additional 'No Trespassing' signs at West Willard and Izaak Walton Way to keep people from entering the sunflower fields.
- Blaine Elkins said that Art Belendiuk is working with DNR on our invasives plan and it should be ready in 3-4 months.

The meeting was adjourned at 9:35pm.

#### FeederWatch Season 2023-2024

Project FeederWatch, now in its 13th year at the Chapter, helps B-CC participants, and Cornell Lab of Ornithology scientists, learn about winter bird populations at the Conservation Farm. The data collected over the winter expands the database used at Cornell to determine increases and declines in the numbers and distribution of bird species in the United States and Canada. This year the counting season takes place from Saturday, November 4, 2023, through Sunday, March 31, 2024. Participants count birds on our sunflower and suet feeders from the comfort of the chapter house, typically on two consecutive weekend days for an hour or so each day. Larry Anderson, Wildlife Chairman, maintains the feeders behind the chapter house. The feeder station was created several years ago as an Eagle Scout project.

Participants can count as often or as infrequently as their schedules permit. Collecting data on our feeder visitors even once or twice during the winter months can have value for the scientists who analyze it. Newbies unsure of their bird identification skills can be paired with experienced counters for mutual support and enjoyment. #### **Volunteers Needed**

**DRAGNet Global Research Study Work Day** (Disturbance and Resources Across Global Grasslands Network)

The IWLA board approved a research study to occur on our Farm to assess the factors that influence plant community recovery after disturbance in grassland ecosystems. Six, 5x5m plots will be weed whacked, hoed, and tilled on the site, which is near the Boy Scout camp and is located in the field across and down from the original chestnut tree enclosure. On Saturday, November 4th (rain dates – November 5 & November 18, 2023), we will hold a work day (8:30am to 4:30pm) to help with the second year experimental treatments for the project. ## Reducing Body Visibility – Becoming One with the Woods

- How would you like to be able to spot your quarry first and choose the best moment for your shot or taking a photo?
- Would you like to have squirrels pass by 10 feet away, climb a tree, and not bark at you?
- How about foxes trotting by at less than 6 feet or be close enough to kick?
- How would you like to watch a raccoon family walk up in a creek bed and not even realize you are only feet away; or have birds - a turkey, a great blue heron, and songbirds land near you and be totally unaware of your presence; or deer walk by you at less than 15 yards or even 10 feet and not be spooked?

All this may happen while sitting or standing on the ground. Becoming One with the Woods is something that Mark Gochnour has been practicing for several years. These concepts can be easily applied so that others can enjoy these types of experiences.

In this family friendly workshop, Mark will share his techniques with participants. Use this opportunity to develop your own skills so that animals will not be as aware of you taking shots of them with a camera or a weapon.

#### **Wildlife Committee Report**

The 2023-2024 hunting season is upon us. Several seasons are already open; deer archery, dove, squirrel, and deer muzzleloader is coming up, October 19th through October 28th (Sunday, October 22, archery only until 10:30am). All chapter members wishing to hunt on our farm must:

- Have a valid MD hunting license (including all necessary stamps, i.e. HIP stamp for doves or Muzzleloader stamp for deer)
- 2) Have a current and valid B-CC IWLA membership card as proof of permission to hunt on pri-vate land
- Have a current and valid parking sticker displayed on their vehicle
- Register on our website to acknowledge understanding our rules and property boundaries. This is a yearly requirement.

We are a large chapter with many hunters and nonhunters that all enjoy a day in the field, so we ask that everyone be safe, courteous and respectful in their activities on our farm. We adhere to and endorse MD DNR hunting regulations and policies. The MD hunting regulations can be found at: http://www.eregulations.com/maryland/hunting/ and can be downloaded on our website. Again, there are not many changes to the MD DNR hunting regulations this year from last. The bag limit remains at 2 antlered deer per year across all hunting seasons (archery, muzzleloader, and firearm) and only one of those deer may have fewer than 3 points on one antler. In region B (our farm is in Region B), hunters may purchase a bonus antiered deer stamp that allows harvest on 1 (one) additional antlered deer. The bag limit of antlerless deer is now unlimited for archery seasons (we are in the Suburban Deer Management Zone), 10 for muzzleloader seasons, and 10 for shotgun seasons.

Our farm is considered private property (MD-DNR land code 430 for harvest check in), so your current valid membership card is used as the written permission to hunt as required by MD DNR and must be carried along with your valid hunting license. Also, a current B-CC IWLA chapter vehicle decal must be visible in all vehicles on the farm. We ask that deer and turkeys taken on our farm be recorded either in our game logbook, located outside the chapterhouse's main door, or by sending an email to andupton9@hotmail.com. When reporting your deer or turkeys, we ask for the following information; your name, doe or buck (antler count), date and weapon used, and the total number of ticks found on the ears of your deer. Other details may also be included such as estimated weight or unusual features.

Please report any sightings of bears on our farm to the wildlife committee; we had numerous sightings last year, and we like to believe our habitat is healthy enough to support an occasional bear or two. Bears in Montgomery Co. are protected and should not be harassed.

The farm committee has been busy tending the fields to improve habitat and attract a wide variety of wildlife to our farm. Once again, Phil Taylor and all the volunteers working with him have worked hard to prepare our farm for hunting seasons. Thanks all!

The plantings benefit all wildlife, including our deer population; several nice bucks still in velvet have been seen checking out the fields. We have several salt block stations out and they are being well used. We do ask that our members do not place salt blocks in our fields; they wreak havoc with our crops and equipment. As a reminder, we do not allow baiting on our farm.

Anyone that has been in the woods in the last several weeks already knows that this year is being considered a good to heavy mast year. Acorns, hickory nuts, walnuts, and a wide variety of soft mast (persimmons, paw paws, and many types of berries) are in high abundance this year. One consequence to a high mast year, according to MD DNR, is that deer harvest numbers are generally lower. The theory is that with abundant food supplies, deer do not search or move as much, making them less visible to hunters.

New this year, the chronic wasting disease (CWD) management area has been expanded to include all of Allegany, Washington, Frederick, and Carroll Counties. The management plan restricts the movement of deer carcasses (or parts) out of these areas. MD DNR recommends common-sense precautions to deer hunters in handling of venison and add that: Concerns over CWD should not stop hunters from enjoying the hunting season or any venison they may acquire. As a reminder, we do not have permission to hunt or go on any of our neighbor's properties. In the event that you need to track and recover a deer that makes it off our farm, members need to get permission before entering our neighbor's property. The property located to the north and west of our farm (near the big pond) on several different boundaries is owned by Joe Morin (301 674-5397), the property located north of the NE Woods is owned by Vikki Van Winkle (301 379-3560), and the property across Willard Road from the NE woods is owned/managed by Bob Cissel (301 775-8978). Members may enter their property only after calling them and receiving permission. You must not enter their properties with a weapon of any kind. The Chapter's Trail Guide on the website is a good way to familiarize yourself with the trails and the boundaries of our Conservation Farm. If you are caught trespassing, you will lose your privilege to hunt and may lose your membership. Trespassing on posted property is a serious crime and punishable under Md. Criminal Law §6-402. A first offense is punishable by imprisonment of up to 90-days or a fine not exceeding \$500, or both.

#### Archeological Dig at the Log Cabin Dig

On September 16th, several families joined forces with the Archeology and Log Cabin committees to start a new archeo-

logical dig on the property. Our target - to investigate what was below the log cabin in the root cellar to get a better understanding of the cabin's age and history. This was also a chance to provide a fun and educational experience for our members, especially those with young families. In total, we had team members, which 15 allowed us to split into groups; two digging teams for excavat-



ing and two sorting teams screening for artifacts and bagging everything we found. The teams rotated through the day, and everyone got to understand standard procedures for running an archaeological dig.

Our first step was to map the cellar into 2' square sections. This allowed us to keep track of where we found things. We carefully excavated by section, an area of 2 feet by 10 feet along the northern wall of the cellar to a depth of about 10.5 inches. We have previously scanned the area with metal detectors and had several hits, indicating some metallic items were likely present, but we also expected to find ceramics and glass, and if you asked the kid's "treasure".

So, what did we find? At some point we believed that the cellar was filled with loads of dirt mixed with stone and debris. The soil that we removed had many decent sized river stones, suggesting that this soil was hauled in by hand vs being produced by accumulation of decomposing leaves. Also, the soil was not hard-packed clay like typical soil on the farm. Consistent with this, we found two white ceramic kitchen or bathroom tiles included in the mix; we don't believe that these were ever used in the log cabin. We also found lots of man-made materials, primarily chinking (there seems to be several varieties present) but also nails, a triangular hinge (which may have come from a door) and ceramic and glass.

We don't believe that we have excavated enough to reach the original floor of the cellar, but we do now know that the original floor must have been at least 10" lower than it is now. This means that we have lots of work to do. In future events, we will remove the soil and debris from other parts of the cellar with the intention of reaching the original floor, and hopefully discovering any secrets the Cabin may hold.

A big thanks to everyone who participated and organized this event. It was a fun day, and as always, when someone asks their parents "when can we do this again" you know it has been a good day.

#### 2023–2024 ANNUAL BUDGET

As we begin the 23-24 fiscal year, the BOG is presenting to the Membership its Annual Budget in this newsletter.

Here is how the process works. Committee chairs submit budget requests to the BOG for the upcoming year. These requests are incorporated in the next year's budget. Our Bylaws require a mid year "budget review" which is completed in January/February. At this point, we review how we have done so far. We ask ourselves - Did we meet membership goals? Have activities changed? and Do the expense budgets need adjusting? We re-evaluate activities and then make adjustments. At the end of the fiscal year (August 31st), our accountants use our financial data to prepare our IRS filing which is required to maintain our 501C3 status. And then we begin the process again.

The biggest driver in our process is Membership. This is "how many members did we have at the end of the year" and "what do we anticipate for the next year." For the FY 22-23 fiscal year (ending in August 2023), our membership is down about 15% as compared to FY 21-22 (ending in August 2022) from about 930 to 780. The reasons for this vary from other activities returning post Covid to the current economic environment. Our goal for this upcoming year is to maintain current membership levels. This is seen by using similar numbers in the budget. Scott Harmon, our new Membership Secretary, is committed to this goal. In fact, he has already sent out the renewals for next year. He and his committee have committed to reaching the goal by contacting former members to see if we can get them to return as well as looking into other methods of attracting new members. Feel free to contact Scott if you can help. All of us can help the chapter with this goal. Bring a friend/neighbor to a meeting to see all of the benefits that our chapter offers.

Our activities are what appeals to our current membership as well as new members. As mentioned above, each activity chair has submitted estimated costs for what they are going to do to achieve this. For the most part, we have not amended these budgets.

Other items that are included in this budget.

- We are going to hold a "gun raffle" headed by Phil Taylor. We will sell tickets at \$20 for the chance to win 1 of 5 guns. The raffle drawing starts December 26th. A great Christmas present for that person for whom "you don't know what to get."
- A loan from the Legacy Foundation. This loan will cover costs for WSSI to identify and stake out the wetland and stream buffers on our property beyond the limits of the lead abatement areas so we could locate these areas and ensure that we are not performing any activities in these areas that are prohibited by our easements or federal and state regulations. We will have to pay it back over 3 years (starting in September 2024). The impacts of this will be seen in the interest expense in next year's budget (FY 24-25 when the first payment is made) as well as in our current cash flow estimate (as we begin saving for this September 24 payment).
- The cash flow projection shows several items that membership may not know about:
  - Capital Account Transfer (per our Bylaws) 10% of the revenue is to be transferred to the Near Term Capital Fund (a separate bank account from our operating account) for capital investments in the property.
  - o A set aside for future Lead Abatement costs (begun when we increased dues 2 years ago and formalized in our Bylaws). This is put in a separate cash account (Long Term Capital Fund). Lead Abatements must be done in the future at all shooting ranges per EPA requirements. By putting these savings aside now, they will have less impact on the day to the day operations in the future.

o Land Fund donations are not listed in the income statement or the cash flow as they are not available to meet operating expenses.
