- Dan Dutton briefed the BOG on the new water testing plan to get approval to proceed with said new plan.
- Andy Wight placed authorized personnel signs at the kitchen and the ranges (Archery, R&P, and Shotgun). Signs indicate to members that the Committee chair is the point person to authorize use.
- Andy Wight discussed Bob Kelly and Steven Austin's work with the membership team on the transfer amounts for the near and long-term capital funds.
- Carol Hulce Efdimis briefed the Board on the main kitchen usage policy.
- Brief update on the Alarm.com Proposal.
- New board members will be updated on the full history behind the shotgun range.
- Andy sent copies of the current By-laws and the proposed changes to the BOG for review.
- 2 firearm donations were made to the chapter. Raffle tickets will be ordered.
- It was decided to have a Land Fund presentation and telethon this year.
- Treasurer Bob Kelly provided a report on the five account balances (Operating, Management Reserve, Land Fund, Near Term Reserve Account, Long Term Reserve Account).
- Discussed the Sandy Spring Bank acquisition and the potential effect on CD rates we could be privy to.
- There was a request for funds for targets, National Shooting Foundation membership, keys, and decals for 2025.
- Discussion was held on donating to the endowment, youth endowment, family campout, and stamps.
- 1st VP Jerry Murray ensured chapter house doors are monitored when open to prevent wildlife from entering.
- A Scout troop in Gaithersburg (1760) is looking to be chartered. It was recommended that they be directed to Dave Draven, the Chapter's scout liaison.
- There was a question about members' interest in the IT committee. This will be put back in the newsletter.
- Shannon Novak is still looking for a few volunteers for the Membership Drive Committee.

- Motion to approve the use of 50 chairs by Troop 496 for their offsite Eagle Court of Honor. Motion seconded and passed.
- Motion to accept James Keil as a probationary chapter member. Motion seconded and passed.
- Motion to order keys for new members. Motion seconded and passed.
- Motion to order decals for the 2025 renewals. Motion seconded and passed.
- Motion to approve a small target order from National Target and for a nonprofit membership with the National Shooting Sports Foundation for the R&P range. Motion seconded and passed.

- Motion to approve the purchase of 250 raffle tickets to be printed by Print1. Motion seconded and passed.
- Motion to reduce the water quality sampling as proposed by the Environmental Stewardship committee and authorize Dan Dutton to make changes with Fredericktowne Labs. Motion seconded and passed.
- Motion for Scott Harmon to be reimbursed for funds used for renewals. Motion seconded and passed.



SENECA CHRISTMAS BIRD COUNT

On Sunday, December 15, we will host the Montgomery Bird Club (MBC) for a portion of the sixty-fourth Sector 7, Seneca Christmas Bird Count (CBC). The CBC, organized by The Audubon Society, is an annual nationwide event first conducted in 1958. Several MBC birders plus Larry Anderson and Pat McNeilly acting as escorts will meet at 7:00a.m. at the chapter house and set out in two groups for the morning count, which typically lasts until noon. FEEDERWATCH NEWS

The overwintering birds are here, and our 14th FeederWatch season is underway! Counting birds is both enjoyable and educational. Please consider joining other chapter members who count species and numbers of birds observed within species on weekends from early November through late March.

Our data is reported to Cornell University's Lab of Ornithology, along with data submitted from thousands of other participants across the country. Our data helps Cornell scientists analyze shifts in bird species and numbers within species in the United States and Canada. Next Spring the Cornell Lab will publish results by geographic area. Maryland falls in the Lab's southeast region.

We welcome and seek new participants. Please email me if you can help. I will send you our tally sheet and instructions. Count birds for at least an hour on two successive days, or on one day if you are pressed for time, from the comfort of the chapter house. 

B-CC IWLA LAND FUND

Please Contribute to the 2024 B-CC IWLA Land Fund

The B-CC IWLA Land Fund began in 1994 to raise the required funds to purchase 127 acres of woodland on our western border known as the West Woods. Since its inception, the Land Fund has raised over 1,000,000 dollars from past and current members' contributions for the sole purpose of purchasing properties adjacent to our conservation farm. So, yes, our chapter has increased the size of the 366-acre farm it bought in 1949 to its present 624 acres.

All funds donated to the B-CC IWLA Land Fund are used solely for land purchase as articulated by the chapter's bylaws. Further, land fund contributions are tax-deductible and 100% efficient, meaning every dollar goes for its intended purpose.

Nation-wide the overwhelming reason IWLA chapters lose their shooting ranges and hunting opportunities is the encroachment of residential and commercial development. Individually we can't stop the advancement of development towards our present boundaries, but collectively we can, and we have. So yes, by coming together as a membership, we will preserve the opportunity for present and future generations to enjoy our lifestyle and chosen value system.

Today is October 12th and I was out at the chapter taking care of the bees. It was time to take the Formic Pro treatment out of the hives, test the hives for varroa mites, start preparing the bees for the winter by putting on the mouse guards, and feeding the bees if necessary.

I was pleasantly surprised by all honey that was on the hives. This is the time of year that I feel I need to put extra sugar syrup on the hives so that they have enough resources to get through the winter. Where did all this honey come from? The answer was not a fall plant blooming, but I found the answer crawling up a tree in the middle of the apiary. It was the invasive Spotted Lanternfly. Hundreds of them. The lanternfly does not produce nectar, but they do produce honeydew when they feed on plants, like aphids. The bees collect the honeydew and use it to produce honey.

The honey produced from the Lanternfly's honeydew tastes smokey to me. Some people like it. Some say it makes great barbecue sauce. I am not a fan of its flavor. I will leave it on the hives as winter resources for the bees and it saves me money in sugar purchases I do not have to make. Is it healthier for the bees? We shall see. I haven't seen any studies to that effect yet.

The Spotted Lanternfly (Lycorma delicatula) are an invasive insect that is believed to have come over to North American in the 1990's from China and Vietnam. They are a plant hopper. It feeds on a variety of plants including soybean, grapes, stone fruits, and the family Malus, which includes apples. From Wikipedia.

Proposed Changes to the By-Laws

(Edits in red – to be voted on at the December 2024 Membership Meeting)

Article III - Membership

Section 2.a Any person may become a Probationary Member upon completion of the following steps. First, the applicant shall attend two regular monthly meetings of the Chapter. For extenuating circumstances, and on a case-by-case basis, the Board of Governors may elect to offer two other meetings that prospective members can attend, in leu of the dinner meeting. Second, the applicant shall file with the Membership Secretary a properly completed application for membership which shall be signed by three (3) Chapter Members in good standing, each of whom shall have been a member for more than one (1) year, one of whom shall be on the Board of Governors, and another of whom shall be over twenty-one (21) years of age. Third, the Membership Secretary shall submit the completed application to the Board of Governors at its next regular monthly meeting. Fourth, the Board of Governors shall review the application and make its recommendation to the Chapter Membership at the following regular monthly meeting of the Chapter. Fifth, the applicant may be accepted for Probationary Membership by affirmative vote of a majority of the members present and constituting a quorum. Sixth, after being properly sworn in, an accepted applicant shall become a Probationary Member upon payment of the appropriate amounts of monies as prescribed in Article VIII of these By-Laws. (Adopted August 16, 1972; amended February 16, 1977, January 19, 1983, February 21, 1991, and July 1992, September 2006, December 18, 2024)

Article VI – Nominations and Elections

Section 1. The President shall appoint an election committee in by March of each year to develop a slate of candidate chapter officers and perform other duties as prescribed herein related to the election of chapter officers and members of the Board of Governors.

Article VIII - Initiation Fees, Dues, Charges

Section 2. Dues. The yearly dues for membership in this Chapter shall be as set by a majority vote at any regular monthly meeting of the Chapter members, a quorum being present, provided a written statement of the dues to be proposed shall be contained in the notice of the meeting. The yearly dues shall be payable on or before January 1 of each year and shall include the annual National Membership dues and the annual Maryland State Division dues. Under special circumstances and at the Board of Governors discretion, a member's chapter dues may be waived in return for services to the Chapter. National and State dues obligations would still need to be met by the member. This would be reviewed on an annual basis. - (Adopted February 17, 1971; amended October 1972 and February 16, 1977, September 2006, December 18, 2024)

Section 3 Membership requirement – All chapter members are required to provide no less than six (6) hours of volunteer chapter work per year per fiscal year (September – August) to maintain their chapter membership. Youth, Student, Associate and Probationary Members are exempt from this requirement. Family Members are required to provide one two six-hour work requirement. (Adopted September 2006, amended)

Article XI – Committees

Section 1. The Operations and Conservation Committee shall be chaired by the Chapter First Vice President and include the following: Chairpersons of Building Maintenance, Security, Equipment Maintenance, Grounds & Roads Maintenance, Farm, Ponds and Streams, Save Our Streams, and Nature Trail, and Environmental Stewardship. (Amended October 2003, December 18, 2024)

Section 3. Committee Chairs are responsible for overseeing the operations, activities, and objectives of their respective committees. Their role includes organizing events, managing the maintenance and safety of facilities and assets, and ensuring that committee goals align with the chapter's mission of conservation, education, and community involvement. They also coordinate volunteer efforts, ensure easement compliance, promote safety and best practices, foster member engagement, and drive initiatives to recruit new members, ensuring the continued growth and success of the chapter. (Adopted December 18, 2024)

Article XII - Quorum

The presence of forty five (45) members 5% of the voting members at any regular monthly meeting, or an electronic response by a minimum of 25% of the voting members shall constitute a quorum for the transaction of business, except as otherwise provided in these By-Laws. In addition, at the Board of Governors discretion some votes may be carried out electronically in conjunction with, or apart from the Dinner Meeting. In this case, notice and link will be included in newsletter preceding any vote. (Adopted July 15, 1970, amended December 18, 2024)
